The provisions of paragraph one do not apply to labels of controlled label products produced for export and Not for sale in Thailand

Section 4. Labels of products that are personal computers must specify the following information:

- (1) The name of the type or type of the product that clearly shows what the product
- is. (2) The name or trademark registered in Thailand of the manufacturer for sale in Thailand.
- (3) The name or trademark registered in Thailand of the person who ordered or imported the item. Kingdom for sale (4) In the case

of imported goods For imports, please specify the name of the country of manufacture.

- (5) Location of the producer for sale. or of the person giving the order or goods imported into the Kingdom for sale (6) must show the size or dimensions or quantity or volume or weight of the goods, as the case may be, for the unit used Will use full name or initials. or wildcards
- (7) Product details To make consumers aware of the features that respond to use namely
 - (a) Screen size (Screen Size)
 - (b) Central Processing Unit (CPU)
 - (c) Graphics Processing Unit: GPU
 - (d) Main memory consists of permanent memory (Read

Only Memory: ROM) and temporary memory (Random Access Memory: RAM)

- (e) Secondary memory (Secondary Storage) (g) Operating
- system (Operating System : OS)
- (8) Must show how to use it. So that consumers can understand the purpose of use correctly.
- (9) Recommendations for use or storage. so that consumers can use the product correctly
- (10) Date, month, year of production, unless the exact date of production cannot be specified. Please specify only the week.

 and year of manufacture or month and year of manufacture To understand the benefits of the quality or properties of that product
- (11) This product is continuously developed. It may affect the production or cancellation of product production. and spare parts in the future For information (12) Other statements as follows:
 - (a) The period for guaranteeing the quality of the product from the date of purchase, for example, 12 months^ÿor years. (b) The period for reserving spare parts for use in replacing parts, from the date or month of manufacture,
- for example, 12 months or year and related details except computer equipment
 - (c) Telephone number of the service center For the convenience of consumers in receiving services

(d) In the case where the product does not have a service center in Thailand Must specify the message: "Such products There is

no service center in Thailand." (13) Price, specifying the unit in baht. and the units may be specified in other currencies as well. The display of text in (10) must be displayed in order of day, month, and year. The "month" may be displayed as numbers or letters. For "year", specify as "B.E." or "A.D. ." In the case where days, months, and years are displayed not in order, there must be text or characters that clearly communicate to consumers the method. Display the

said message as well. Displaying the message on the product label must be clearly visible and legible. The size of the letters used must be Relative to the size of the label area And the height of the letters must not be less than 2 millimeters, except in the case of labels with an area of less than 35 square centimeters. The height of the letters must not be less than 1.5 millimeters.

Item 5. Labels of products that are computer equipment must indicate the text in Item 4, except for the text in Item 4. (7) Item 6. In

the case where the label of the product with label control cannot be displayed correctly as specified in Item 3, Item 4. and item 5 must be included in the same location. For example, if it cannot be displayed on all products, it must display text, images, artificial marks, or images of any kind. in any part of the product or container or package containing the product, or inserted or included with the product or container or product packaging or in documents or manuals for use with products or installed signs or displayed on the product or the container or package containing the product But when the labeling is included everywhere, it must be able to be clearly seen and read. Clause 7 This announcement shall

come into force after the expiration of the label. The period is one hundred and twenty days from the date of announcement.
